# TERMS & CONDITIONS OF ENTRY AND SALE OF PAINTINGS

PLEASE READ **ALL** THE TERMS & CONDITIONS CAREFULLY!

- ENTRIES** – Entry to this Awards Exhibition is restricted to current members of the member Societies of the Combined Art Societies of Sydney Inc. A current list of members is available at <http://combinedartsocieties.com/members/> Eligible artists may submit a maximum of **five (5) paintings**
- SECTION REQUIREMENTS FOR MEDIUM AND SUBJECT:**
  - Section 1. Oil or acrylic painted as oil.** Any subject in a traditional or contemporary mode will be accepted. May be framed or deep edged canvas. Abstract work will NOT be accepted in this Section.
  - Section 2. Water Medium – painted using watercolour techniques** - includes watercolour, gouache, ink or acrylic painted as watercolour. Any subject in a traditional or contemporary mode will be accepted. May be framed, or deep edged canvas. Abstract work will NOT be accepted in this Section.
  - Section 3. Drawing and Mixed Media** includes charcoal, pastel, ink, paint and collage on any surface. Prints are accepted. Works highly textured or with protruding collaged elements may not be accepted by decision of the committee if it is determined the work itself be damaged or may damage other works during storage or transportation. Any subject. May be framed or deep edged canvas. Abstract work will NOT be accepted in this Section.
  - Section 4. Abstract.** Any medium. The artwork should not represent scenes or objects naturalistically, even in an extremely distorted or exaggerated way. The artwork should be based on colour, shapes, brushstrokes, size, scale, process. Prints are accepted. Works may be framed or deep edged canvas.
  - Section 5. 9" x 5"** - Any medium, any subject. The image, irrespective of framing, must be 9" x 5". An artwork on canvas board or stretched canvas may be up to ¼" less each side to account for the rebate of the moulding, that is, the exposed image may be no less than 8.5" x 4.5". **PRINTS** - the exposed image for prints in this section will be measured excluding the white space used for the title, the edition and the signature. All works must be framed. Abstract work will NOT be accepted in this section.
  - Section 6. Miniatures** – Any medium, any subject. The artwork image size must be no more than 100sq cm (10cm x 10cm or any variation less than this). **PRINTS** - the exposed image of prints in this section will be measured excluding the white space used for the title, the edition and the signature. The artwork shall depict an object or person in nature, painted in a traditional mode in the spirit of miniaturisation. All work must be framed. Abstract work will NOT be accepted in this section.
- NUMBER AND SIZE OF WORKS**

Each artist may submit a total of 5 works. **There is a maximum of only ONE (1) LARGE PAINTING per artist.** No entry shall exceed 310cm in perimeter. This measurement is obtained by measuring around the outside edge of the frame on the painting or, in the case of unframed canvas, around the edge of the painting.

**Size of your large work will include paintings with a perimeter of 260cm to the maximum size perimeter of 310cm. One (1) only large painting may be submitted by each artist.**
- FRAMING**

Exhibits must be dry and properly framed. To maintain the standard of excellence in this exhibition, poorly framed works will not be considered for judging or inclusion in the exhibition. Screw eye fittings and uncovered wire will not be accepted. Only non-metallic frames with Stapled or D-ring fittings with soft cord or plastic-coated wire will be accepted. **All metal on the back of your painting, including staples, must be covered.**

***Please make your framer aware of these conditions and the size restrictions.***
- DEEP EDGE CANVASES** – artworks must be dry and may be entered unframed on Deep Edge 38mm (1½") artist quality stretched canvas, professionally stapled at the back. It is desirable that each deep edge canvas be fitted with a backing board, but the decision to do this is that of the artist - **the CASS will take no responsibility for damaged canvases.** Sides of the canvas must be painted thoroughly, cleanly and neatly. **Narrow edged canvases, regardless of size and shape, must be framed. Unframed, narrow edge canvases will not be accepted. Only paintings with soft cords, professionally stapled, or with D-ring fittings and soft hanging cords, or 'plastic coated' wire, will be accepted.**
- ORIGINALITY** – Entries must be the original work of the artist and have been completed in the 12 months prior to the exhibition. Copies of any other person's work or paintings produced in workshops will not be eligible for judging or inclusion.
- ENTRY FEES** – A non-refundable entry fee of \$20.00 will apply for each exhibit entered with the exception of the Miniature Section. **Fee for one (1) miniature single artwork is \$20.00. As a bonus – the fee for two (2) miniature exhibits will be \$20.00 for the two (2) artworks.**
- RESUME** – Artists are asked to include a current **A4 size** resume with their work to include in the CASS Resume folder for viewing by the public during the exhibition.

9. **IDENTIFICATION OF PAINTINGS** – All entries must be clearly labeled on the back. Affix the labels provided to the BOTTOM right hand corner at the back of each painting - when the painting is face down.
  - Title, Medium and Price
  - Section for entry
  - Name of artist
  - Name of the Society to which the artist belongs
10. **COMMISSION** – 30% commission will be charged on all sales. 25% will be retained by the CASS and 5% will be donated to CareFlight. All works entered must be for sale.
11. **GST COMPLIANCE** – At the time of printing this form, CASS is not registered to collect GST. Therefore as an artist, if you are registered for GST, please include the 10% GST in your listed price, and CASS will pay the relevant amount of GST to you along with any money owing to you from sale of paintings.
12. **WITHHOLDING TAX** - The Australian Taxation Department requires CASS to withhold 48.5% of money owing to an artist as a result of a painting being sold unless the artist has quoted an ABN, or is a hobbyist as defined under the Act. Please ensure you have completed the Artist's Declaration in full on the Entry Form, and **included a "Statement by Supplier" Form if you are claiming to be a Hobbyist.**
13. **SELECTION OF PAINTINGS** – will take place on **Saturday 5<sup>th</sup> January 2019**, at **Bankstown Art Society, Olympic Parade, Bankstown**. The Combined Art Societies Selection Committee, made up of one Representative from each of the 'Member Societies', reserves the right to preselect entries prior to the Judge's final decision. The selectors are required to do their own individual selection – their decision is not a group decision. Each Selector must mark off any painting they believe not to be to the standard required for the Art of Sydney Exhibition and once 50% of the selectors have marked off that painting it will be removed from the exhibition.
14. **JUDGING** – will take place on **Sunday 6<sup>th</sup> January 2019**, at the Bankstown Art Society, Olympic Parade, Bankstown. Prior to the judging all paintings removed by the Selection Committee will be viewed by the Judge. The Judge will have the option and the authority to reinstate paintings.
15. **SELECTED PAINTINGS** – Paintings selected for hanging at the Art of Sydney Awards Exhibition will remain in storage at the Bankstown venue until the exhibition date, at which time the committee shall arrange for transportation to the venue.
16. **NON-SELECTED PAINTINGS** – Artists, whose paintings are **NOT selected, will receive a phone call** from the Organizers on the Sunday 6<sup>th</sup> January 2019 **between 1pm and 2pm**. Non-selected paintings must be picked up on **Sunday, 6<sup>th</sup> January from the hall at Olympic Parade, Bankstown between 2pm and 4.30pm**. Please ensure the phone number where you can be contacted on the day is shown clearly on the Entry Form. **Non-selected paintings cannot be stored at the venue.**
17. **INSURANCE** – The Combined Art Societies of Sydney Inc will take all reasonable care with all exhibits submitted, but will not be responsible for loss of, or damage to, any such work while in their custody, nor for insurance of exhibits either in transit or on exhibition. Exhibitors requiring insurance should make their own arrangements in regard to this matter.
18. **DELIVERY** - All entrants are responsible for delivery of paintings to – **Bankstown Art Society, Olympic Parade Bankstown**, and collection of non-selected works. Entries must be delivered to CASS free of charges. No payments will be made by the CASS committee for freight or other fees incurred during delivery and / or return of paintings.
19. **END OF SHOW PICK UP – Sunday, 27<sup>th</sup> January 2019 – 5pm**. Unsold paintings are to be picked up by the Societies and not by individual artists. One vehicle only from each Society will be allowed to park outside the Australian National Maritime Museum while paintings are loaded. Paintings may not be removed from the exhibition by individual artists. Arrangements must be made within each society for artists to pick up their work from their own Society's venue.
20. **PUBLICITY** – The committee reserves the right to allow reproduction by the CASS, the media or TV, and the CASS official photographer, of any entry accepted for hanging.
21. **ROSTER - It is a Condition of Entry that all exhibiting artists volunteer a minimum of 3 hours to assist during the course of the Exhibition, either at Bankstown - on the selection & judging weekend – OR – when loading paintings to go to the show Oatley - to assist loading art screens Drummoyne - to assist loading art screens and lights and particularly at the Australian National Maritime Museum during the exhibition hours.**  
**IMPORTANT – it is vital that your Society is represented throughout the whole day when your Society is on Roster. See page 7.**
